



COMING TO CANADA THIS SUMMER?

WE KNOW THAT THE RULES SEEM TO ALWAYS BE CHANGING BUT... HERE'S WHAT YOU NEED TO KNOW: **EFFECTIVE 28 FEBRUARY 2022**

- You must use the [ArriveCan](#) app or website to enter your personal information.
- You must be fully [vaccinated](#) with an approved vaccine and have received your last dose at least 14 days prior to the day you enter Canada.
- In addition to your ArriveCAN receipt, travellers should carry your actual vaccine certificate with you to show officials at the border entry point.
- You must have a negative [Covid-19 test](#) result to meet pre-entry requirements. Travellers will have the option of using a Rapid Antigen test (taken the day prior to entering Canada) or a PCR molecular test (sample must be taken within the 72 hours prior to entering Canada.)

Note: Taking a Rapid Antigen test at home is not sufficient - it must be authorized by the country in which it was purchased and must be administered by a laboratory, health-care entity or telehealth service.

- All travellers 5 years of age or older must provide a negative Covid-19 PCR test result.
- Or proof of a previous POSITIVE test result taken between 15 and 180 days prior to your planned date of entry. The proof of the positive result must be from an accepted type of molecular test.
- Vaccinated travellers who meet the requirements will be exempt from quarantine; however, all travellers must still provide a quarantine plan and be prepared to [quarantine](#), in case it is determined at the border that you do not meet the necessary requirements.
- You may be randomly [selected](#) to complete a Day 1 Covid-19 molecular test upon arrival into Canada.

If you are randomly [selected](#) to complete a Day 1 Covid-19 molecular test upon arrival into Canada, you must take the arrival test as directed on the day you enter Canada. If arriving from the USA you don't have to wait for the results and you can proceed with travel to QCL.

- All passengers on flights departing or arriving at Canadian airports are required to wear a non-medical mask or face covering that covers your mouth and nose.

RETURNING TO THE USA AFTER YOUR VISIT TO CANADA:

- As your trip to Canada will be longer than 3 days after the PCR test, you will need to be retested (antigen or PCR accepted) before your return flight to the USA.
- All [airline passengers](#) to the United States ages two years and older must provide a [negative COVID-19 viral test](#) (antigen test acceptable) taken within **one day of the departure** of your flight to the USA. Note that the test requirements include taking it within one calendar day and is not limited to within 24 hours of your departure. This means that passengers will be able to take their test at any time during the day before their flight, no matter what time their flight departs.
- Assuming you will need to obtain a rapid-antigen Covid-19 test done prior to your return flight to the US, we suggest you make an appointment to be tested at the YVR Main Terminal, either upon your return to Vancouver from QCL or before your flight to the USA.

- American guests driving to the United States are not required to provide a negative Covid-19 test at the border.
